

### Sector Highlights

- The residential building products distribution industry is segmented into several subsectors. This report will focus on exterior products, interior products, lumber and building materials ("LBM"), and hardscape / landscape suppliers.
- Primarily serving pro dealer contractors in the new construction and remodeling markets, these distributors provide a critical link between suppliers and a highly fragmented customer base.
- Given the regional nature of the markets, the distributor base has historically been fragmented as well.
- The past 2 decades have seen considerable consolidation, leading to well-capitalized super-regional and national players in each subsector.
- These larger firms are a combination of private equity backed consolidators, public companies, and privately held entities, creating an interesting dynamic for independents looking to be acquired and a ready exit strategy for smaller consolidators.
- While the sector experienced unprecedented activity post-COVID, rapid inflation in the U.S. economy drove the Federal Reserve to impose significant interest rate hikes, resulting in the highest rate in more than twenty years.
- Mortgage rates have more than doubled over that time, dramatically increasing the cost of ownership for homebuyers.
- Economic concerns have resulted in fewer housing starts, which, combined with a hesitancy for existing homeowners to swap a low rate for the current higher rates, have reduced housing inventory and resulted in stubbornly high housing prices.
- Despite the current disruption faced by the housing markets, there remains systemic issues with housing shortages in the U.S. Household formations have outpaced housing starts, resulting in all-time lows in rental and homeowner vacancy rates.
- The prevailing sector dynamics suggests longer-term tailwinds for housing construction and remodeling.
- We anticipate continued M&A as larger consolidators and platforms pursue continued growth in core areas of focus and / or seek to enter adjacencies (ex., HVAC, expansion into commercial building).




### Rising Interest Rates Creating Uncertainty

- Rapidly rising inflation rates of 2021 and 2022 led to swift and significant rises in interest rates - since March 2022, the Federal Reserve has increased its benchmark rate 11 times.
- In the Fall of 2023, the average 30-year fixed rate mortgage exceeded 7%, levels not seen since before the financial crisis of 2008.
- Despite the rapid rate increase, housing prices have not fallen appreciably. Many homeowners are reluctant to trade out historic low mortgage rates. Further, starts are down as builders pull back in the face of economic uncertainty. These factors have combined to reduce supply, while demand has remained high.
- Homeowner vacancy rate, defined as the proportion of homeowner inventory that is available for sale, is less than half of what it was a decade ago at below 1%.
- While the growth in multi-family units has helped offset some of the shortages in the housing markets, household formations continue to outstrip housing starts. By some estimates, there is a gap of more than 2 million available units, which suggests long term tailwinds in the market, once the current environment stabilizes.

### **U.S. Average Mortgage Rate**


Monthly, 30 Year Fixed Rate


### **U.S. New Housing Starts**

Monthly, not Seasonally Adj. (Thousands of Units)




### U.S. Median Home Sale Price

Quarterly (Percentage)






### Consumer & Builder Sentiments are Recovering

- Inflation in the supply chain for building material and supplies dealers has come down from the skyrocketing prices of the last few years, although is still trending above the 10-year average according to the Purchase Price Index.
- Builders' confidence dropped sharply in the spring and summer of 2022 as a result of the rising interest rates. This changing sentiment led to a reduction in starts as discussed previously.
- Builders' confidence has rebounded in recent months, although remains below the 10-year average.
- Interestingly, consumer confidence was less affected over the past twelve months, signaling the consumers are less concerned, likely due to continued low unemployment rates and the relatively and unexpectedly strong economic performance.

### **Consumer Confidence Index**




### Purchase Price Index - Building Material and Supplies Dealers Monthly, Not Seasonally Adjusted



### Favorable Housing Dynamics Remain in Place

- Following a steady decline after the 2008 recession, home ownership has been trending up in the United States.
- The pandemic helped accelerate this trend, with a sharp spike in ownership immediately after the initial impact of COVID, succeeded by a continued steady increase.
- Ownership rates among the younger generations have increased. From 2017 to 2022, cohorts from 20+ years of age through mid-fifties all saw growth in the percentage ownership in their respective categories.
- Importantly the most dramatic share increases came in the 44-year-old and below groups - typical first-time buyers - which each showed 300 to 400+ bps ownership percentage increases.
- These younger home buyers are also a disproportionately large part of the population, representing a significance increase in count from a decade ago.
- These dynamics combine to suggest continued activity in the residential markets, for both new construction and remodeling.


### U.S. Home Ownership Rates by Age

Under 3535 to 4445 to 5455 to 65Over 65


### **U.S. Home Ownership Rates**

Civilian, Noninstitionalized (Thousands)








### Value Considerations for Independents

- Given the fragmentation of the market, one-third of the total deals are for single branch operators and the majority of M&A transactions are for companies with 3 branches or less.
- Key drivers of higher transaction multiples and valuations include:
  - > Total Branch Count
  - > Total Revenue and Revenue per Branch
  - > Geographic Location
  - > Synergies with buyer
- Additionally, multiples vary across sub-sectors and by target based in part on:
  - > Rebate characteristics
  - > Manufacturers and brands represented
  - > Services and products offered
