Avenu was formed in 2017 through the combination of PRA's Government Services division and Conduent's Local and Municipal Government Software Solutions business.

**Washington Harbour Partners** acquires **SixGen** (Annapolis, MD), a provider of cybersecurity products and services to federal and commercial customers. **Capitol Meridian** acquires **Clarity Innovations** (Columbia, MD), a provider of advanced data and cyber analytics services and software to the U.S. National Security community. Clarity acquires **Gray Digital**, a human-centered digital services company to federal customers. **Godspeed Capital** acquires **Crimson Phoenix**, a provider of data and intelligence solutions supporting Intel and U.S. Special Operations Command. Crimson Phoenix has over 400 employees, 90% of whom are cleared at the TS/SCI level. Crimson Phoenix acquires **Cyberspace Solutions** (Herndon, VA), a provider of solutions to U.S. Special Operations Command and DIA.

**ManTech (Carlyle)** acquires **Definitive Logic** (Arlington, VA), a provider of digital transformation consulting and technology solutions to defense, homeland security, and federal civilian agencies. **Accenture** acquires **Strongbow Consulting** (Ridgewood, NJ), a provider of commercial and technical expertise in infrastructure modernization across hybrid cloud, networking, and end-user compute environments. Strongbow will become part of Accenture Technology Strategy & Advisory in North America.

**Amentum** agrees to merge with **Jacobs Solutions**, which is comprised of its **Critical Mission Solutions** segment plus the **cyber and intelligence portions of the Divergent Solutions division**. The new public company will be owned 51% by Jacobs shareholders, 7.5-12% by Jacobs, and the remaining 32.5-37% by Amentum. Combined company will have \$13 billion in revenue and more than 53,000 employees and a projected \$1.1 billion in adjusted EBITDA in 2024.

**Bain Capital** acquires **Guidehouse** (Veritas Capital) for \$5.3 billion. Guidehouse provides management, technology, risk consulting, digital services, and other consulting services to a wide range of industries including defense & security, energy, infrastructure & sustainability, financial services, and health. **Parsons** acquires **Sealing Technologies** (Columbia, MD) for \$200 million. Sealing provides defensive cyber operations, AI, and ML-driven integrated mission-solutions, edge computing, and edge access modernization to federal customers. **T-Rex Solutions** acquires **Cyber Cloud Technologies** (Columbia, MD), a provider of enterprise IT services to the federal government.

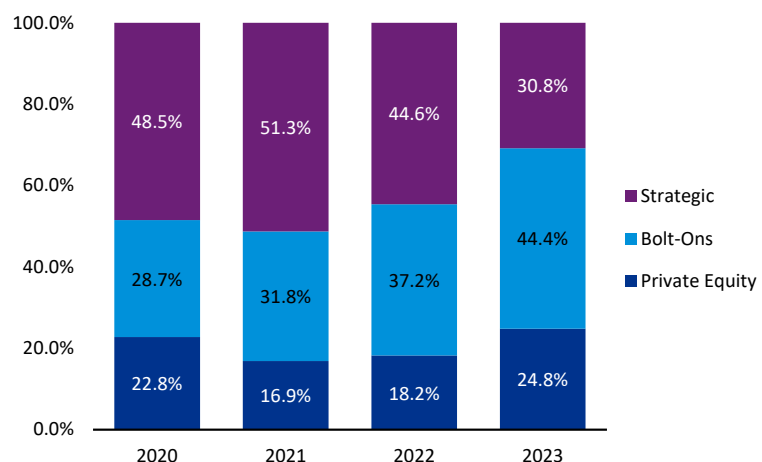
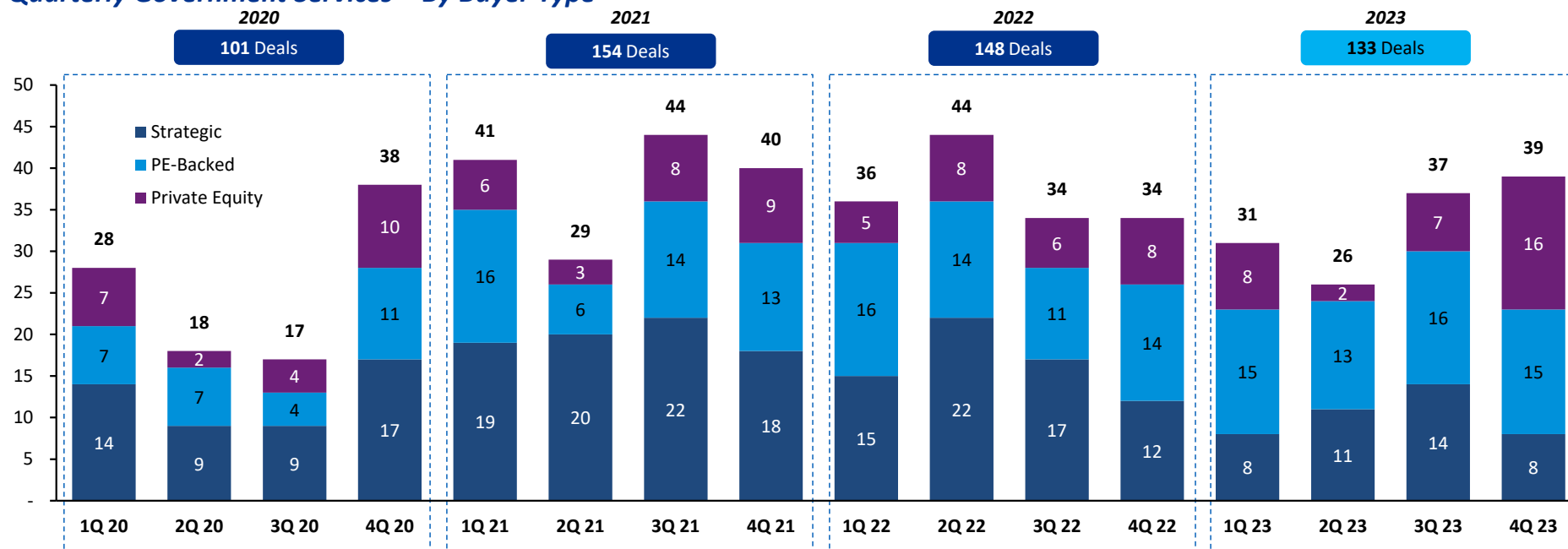

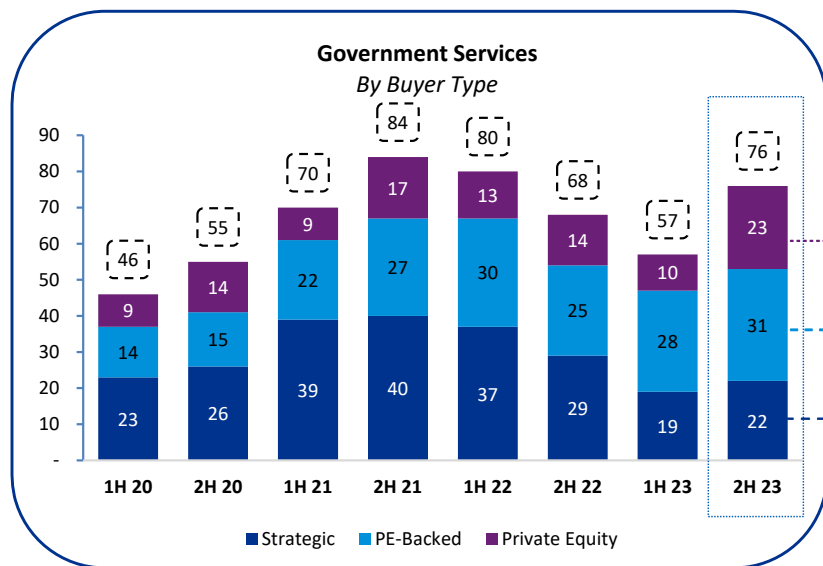
Quarterly Government Services – By Buyer Type



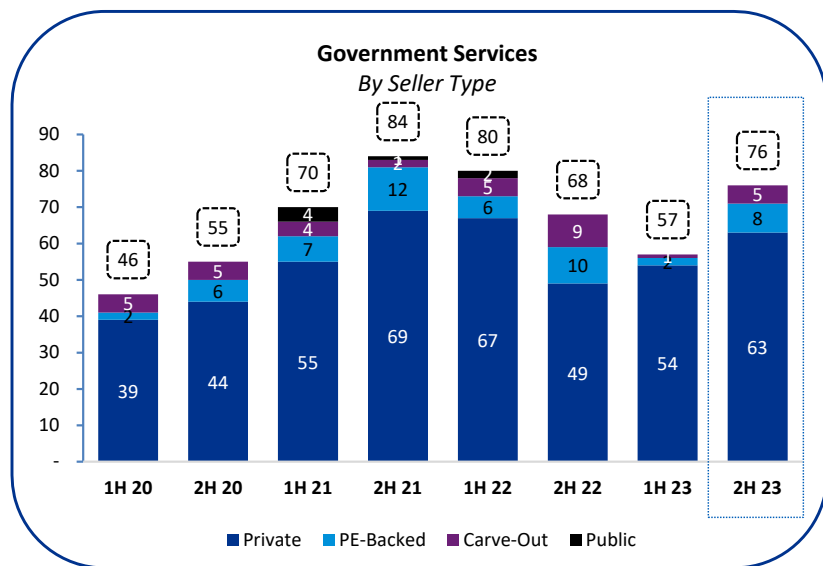
<b>Constant Technological Change in Warfare</b>	While China remains the pacing threat technically & geopolitically, Russia-Ukraine, Iran and its proxies, Israel-Hamas, North Korea and other constant threats require continued vigilance. Key investment themes remain aligned with these threats: cybersecurity, AI, hypersonics, space, intelligence collection & analysis, and other defense technologies.
<b>Continued Private Equity Interest</b>	Private Equity continued to play a key role in Government Services M&A contributing 2/3 of all Government Services M&A activity in 2023 (Platforms: 24.6%, Bolt-Ons: 44.6%). The 2 <sup>nd</sup> Half of 2023 saw 21 new platforms (32 in all 2023) backed by both established and new financial players.
<b>Deal Dynamics</b>	2023 saw a significant volume of deals however many were <\$100m. While strategics were moderately engaged in M&A in 2023, the market expects them to be more active in 2024 as existing PE platforms mature to have the size and scale that larger strategics will find more compelling.
<b>National Defense Industrial Strategy (NDIS)</b>	DoD releases National Defense Industrial Strategy (NDIS) document which notes key themes including fortifying and hardening supply chains, enhancing workforce readiness, improving acquisition strategies, and strengthening economic deterrence, among other key initiatives.

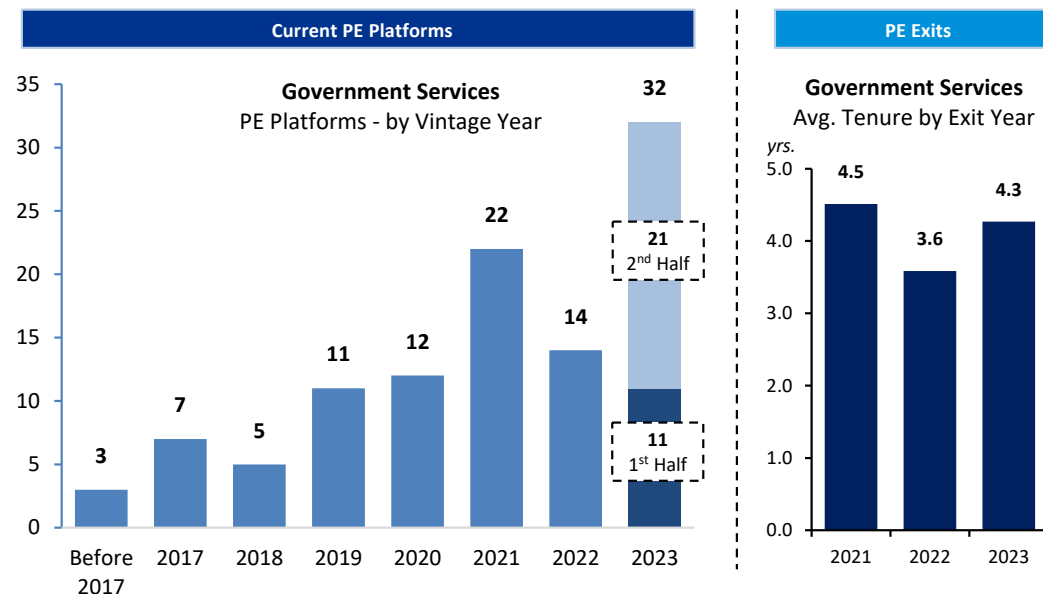

# Government Services – Private Equity Platforms

- The 2<sup>nd</sup> Half of 2023 saw a flurry of Private Equity Government Services platforms with **21 new platforms**, backed by both established and new players.
- In total, for 2023, there were **32** new Government Services platforms.
- There are currently **over 100** PE-Backed Government Services platforms.
- The average tenure of PE exits in 2023 was **4.3 years** and included some notable exits, including:
  - Bain Capital acquired Guidehouse (Veritas Capital) – *Hold* = 5.6 yrs.
  - BigBear.ai acquired Pangiam (AE Industrial) – *Hold* = 3.0 yrs.
  - A&M Capital acquires VTG (The Jordan Company) – *Hold* = 5.9 yrs.
  - System One acquires KeyLogic (Proteus) – *Hold* = 4.5 yrs.

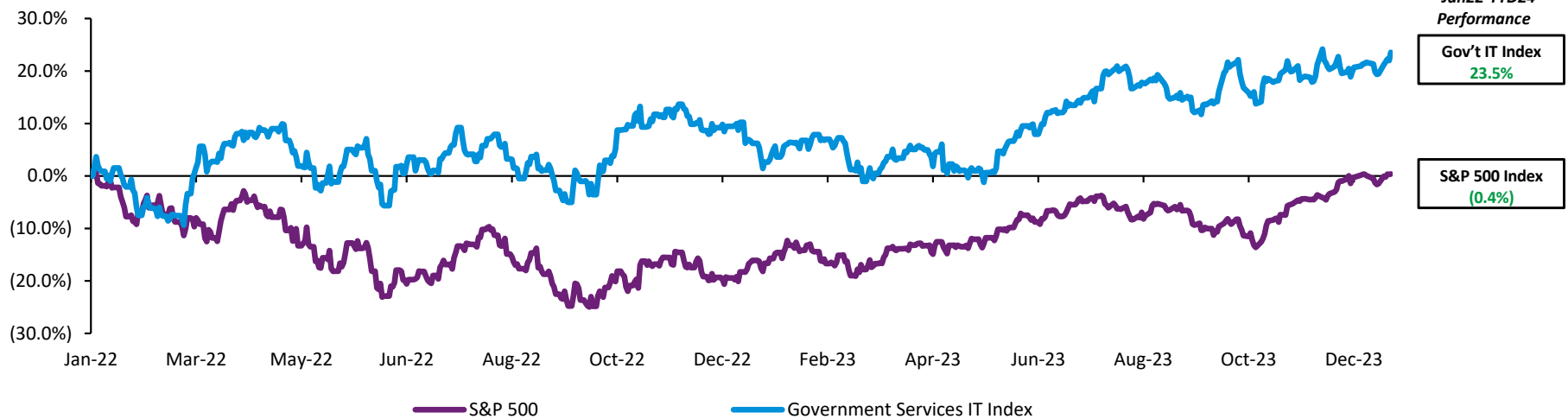

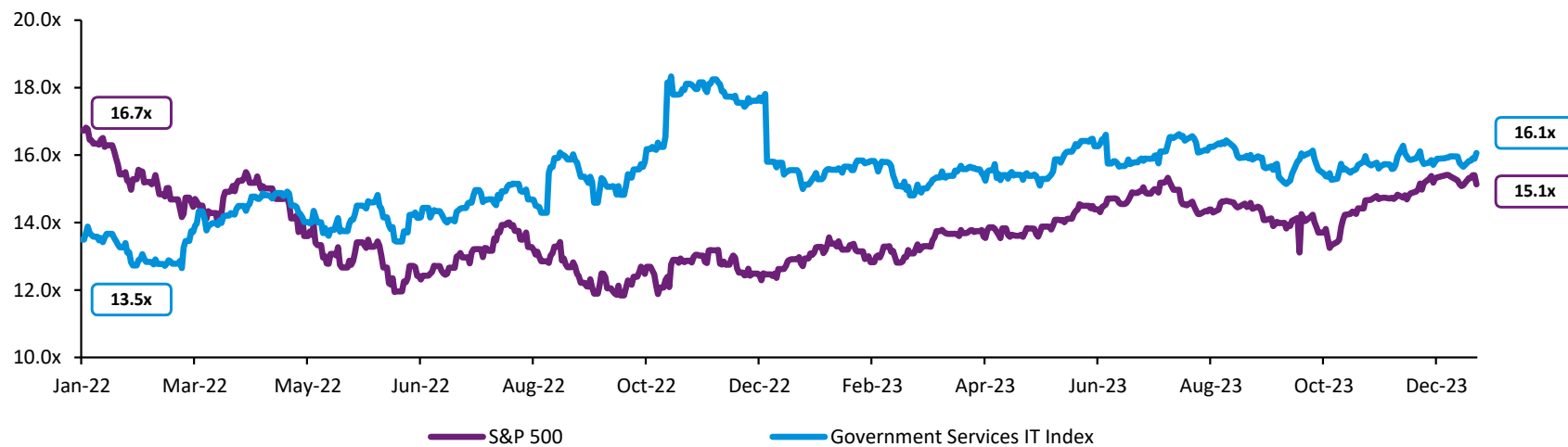

(2022-YTD 2024 Performance)



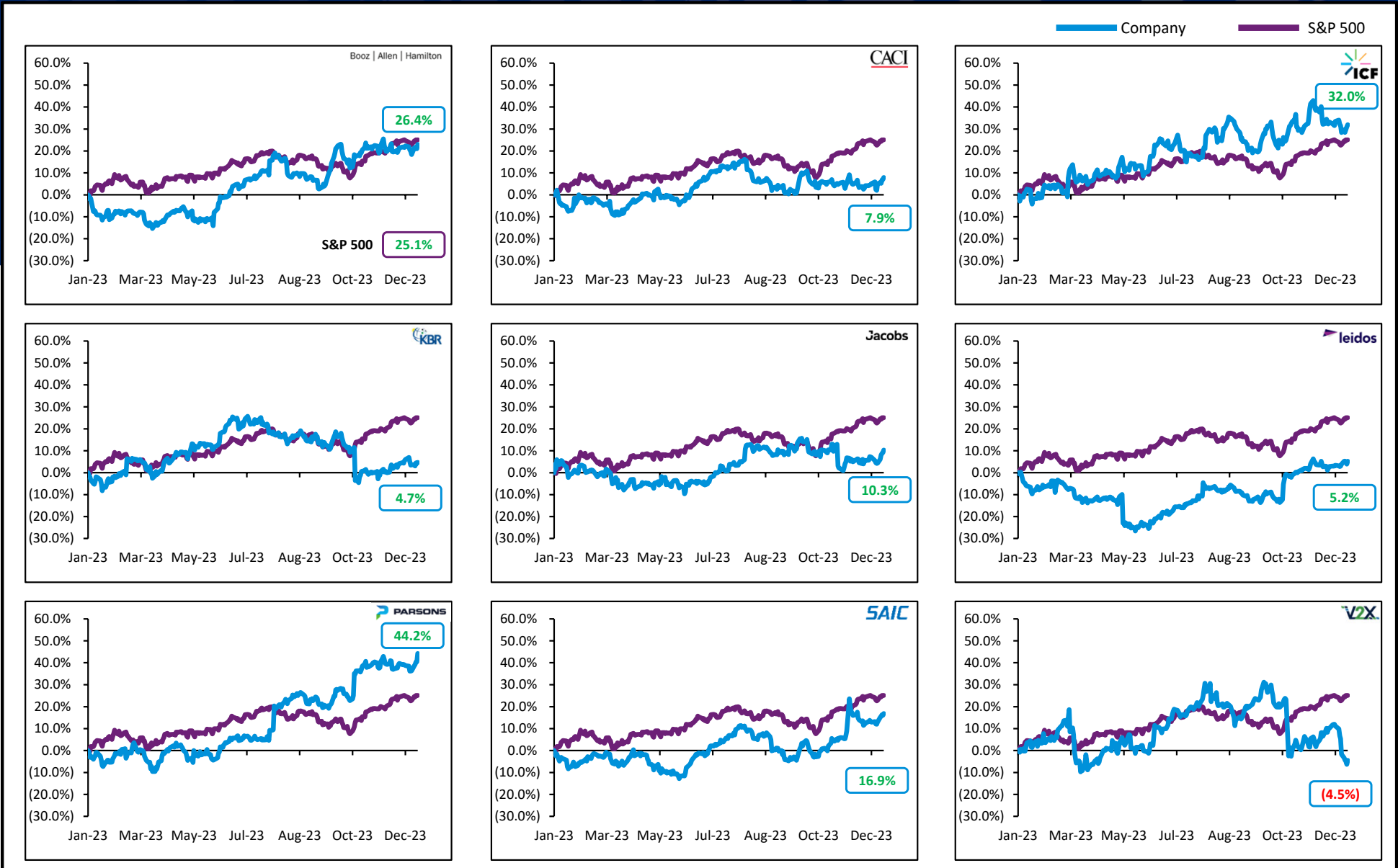
**Government Services IT Index v. S&P 500**

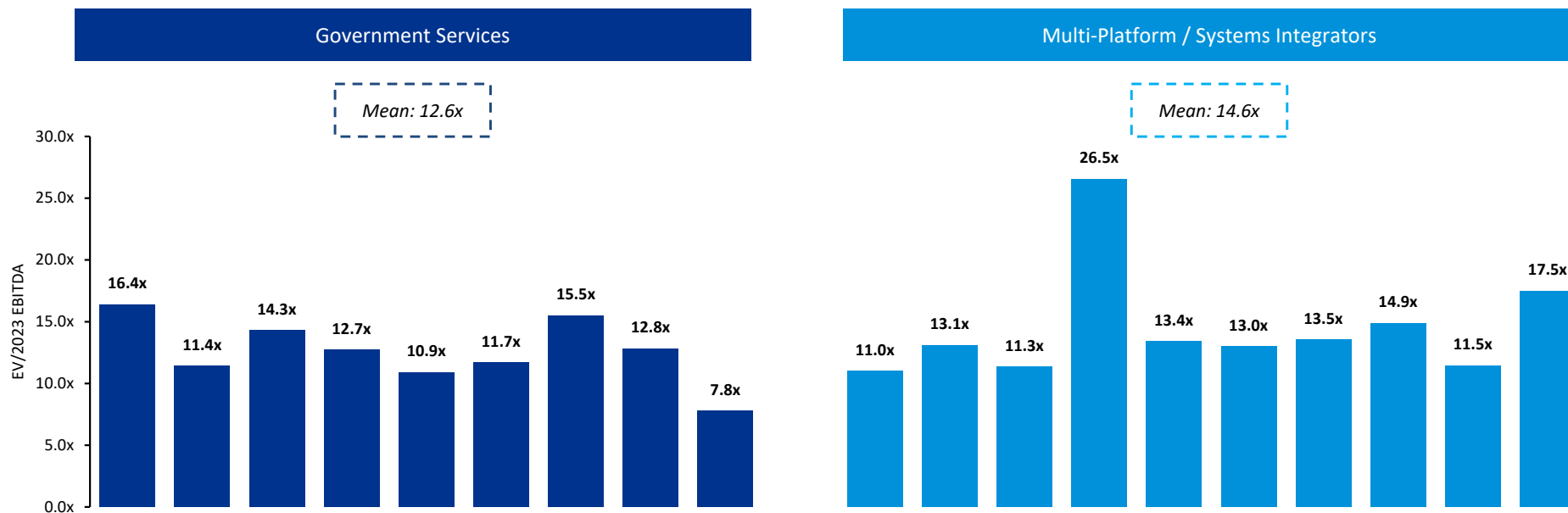

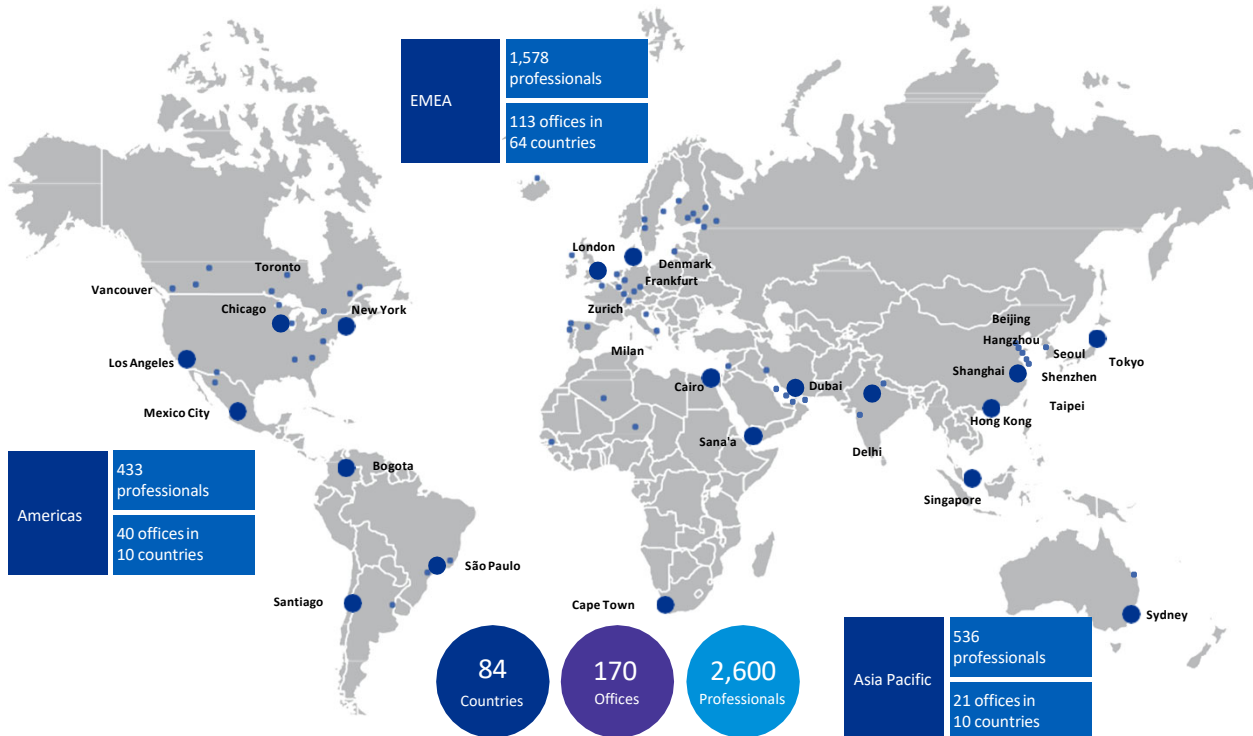
